4. Suppliers must submit their quotes with the following documentation and or information:

4.1 A valid original Tax Clearance certificate;

4.2 Suppliers must submit together with their quotes company registration documentation (CK1).

4.3 A certificate certifying that the bidder has no undisputed commitments for Municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 30 days;

4.4 Bids to hold goods for 90 days.

4.5 Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies.

4.6 MBD 4, 8 and 9 forms must be obtained at Umsobomvu Municipality website and must be completed and signed.

4.7 Bidders must be registered on the Central Supplier Data Base to be able to comply with the conditions of this tender.

4.8 Bidders must also ensure that they submit a recent copy of the Central Supplier Data Report that it is not older than 90 days.

4.8 Suppliers are allowed to submit their bids through on the under-mentioned email due to Lockdown restrictions being applied throughout the country.
