4.2 Suppliers must submit together with their quotes company registration documentation (CK1).

4.2 A certificate certifying that the bidder has no undisputed commitments for Municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 90 days;

4.3 Bids to hold goods for 14 days.

4.4 Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies.

4.6 MBD 4, 8 and 9 forms must be obtained at Umsobomvu Municipality website and must be completed and signed.

4.7 Bidders must be registered on the Central Supplier Data Base to be able to comply with the conditions of this tender.
