- A valid original Tax Clearance Pin.
- A certified copy of Company registration/founding statement/CIPC.
- Certified Copy of ID for Company Directors
- Director's Municipal account not older than 3 months.
- Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies or sworn affidavit, if your business annual turnover is less than R10 Million.
- Certificate certifying that the bidder has no undisputed commitments for Municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 90 days, or lease agreement or if the bidder lives in a rural area, he or she should get proof of residence from the chief of the village of the area;

- Bids to hold goods for 90 days.
- Suppliers must be registered on the Central Supplier Database (CSD) and attached a proof of valid CSD registration report printout be submitted.
- MBD 4, 6.1, 7.1, 8 and 9 forms/declaration of interest be obtained at Umsobomvu Municipality must be completed and signed.
- Address and vat number **4700193941** of the municipality must appear on the quote.
