TENDER NOTICE AND INVITATION TO TENDER

The **UMSOBOMVU MUNICIPALITY** hereby invites individuals/construction companies from civil engineering industry to submit proposals to act as construction managers for the **Upgrading of existing gravel street to concrete block paved road: Louisa Street (0.8km long, 5.4m wide)**, using labour intensive method of construction (**Local Labourers**)

The works will include but not limited to: preparation of the road bed, construction of the sub-base, the base, V drains, edge beams, drifts and packing of 60mm interlocking paving bricks, trimming and re-shaping of the adjacent natural slopes. The contractor must meet the following minimum requirements;

- It is estimated that tenderers should have a CIDB contractor grading designation of **2 CE** or higher,
- Manager with NQF level 5,
- Supervisor with NQF level 2, and
- Admin clerk with MS word and MS excel (computer skills).

Only tenderers who satisfy the eligibility criteria stated in this advert are illegible to submit their proposals

The Umsobomvu Municipality Procurement and Supply Chain Management Policies, the Preferential Procurement Policy framework Act, Act No 5 of 2000 and the regulations promulgated under this act shall apply in the adjudication and awarding of the tender.

A compulsory site inspection meeting with representatives of the Employer will take place at the Municipal offices in, **Noupoort** on **26 March 2015** starting at **10:00 am**. Persons arriving later than **10:15** will not be allowed into the meeting. Only tenderers who attend the compulsory site inspection meeting are eligible to submit tenders.

The closing time for receipts of tender is **12:00** on Friday, **10 April 2015**. Sealed proposals, endorsed with the corresponding tender number and description, must be placed in the tender box in the foyer of Umsobomvu Municipality, **21A Church Street, Colesberg**.

The following tender conditions but not limited to, are also included in the tender documents:

- The tender offer validity period is 90 days.
- Bidders must submit a certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which is overdue more than 30 days.
- The Bidder must supply any particulars of contracts awarded by an organ of state for the past 5 years including particulars of any material non-compliance or disputes concerning the execution of such a contract.
- An original current SARS Tax Clearance Certificate in respect of Income and VAT must be attached to the bids.
- Bidders must have certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents.
- The bid will be adjudicated on the following criteria: Price = 90 points. BBBEE contribution level = 10 points.
