TENDER NOTICE AND
INVITATION TO TENDER

The Umsobomvu Municipality invites tenders from civil engineering contractors for the **Upgrading of the Sewer Reticulation in Norvalspont**.

The works will include the construction of a waterborne sewer reticulation for the entire residential area of Norvalspont, with a gravity main outfall to a new sewer pump station and a new rising main to where the existing pump station and rising main is situated.

It is estimated that tenderers should have a CIDB contractor grading designation of **6 CE or higher**. Contractors registered as potentially emerging enterprises with the CIDB who are registered in one contractor grading designation lower than that required in terms of the total sum tendered are NOT eligible to tender.

Only those tenderers who are registered with the CIDB, in a contractor grading designation equal to or higher than the latest CIDB promulgated contractor grading designation, determined in accordance with the sum tendered will be eligible to tender.

The Umsobomvu Municipality Procurement and Supply Chain Management Policies, the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and the regulations promulgated under this act shall apply in the adjudication and awarding of the tender.

Tender documents may be collected during working hours after 08:00 as from **17 to 20 August 2015**. Tender documents will not be available at the site inspection meeting in Norvalspont and all documents must be purchased prior to the meeting.

A non-refundable tender deposit of R 300.00 payable in cash only is required on collection of the tender documents. Only tenderers who attend the compulsory site inspection meeting are eligible to submit tenders.

The closing time for receipt of tenders is **12:00 on Friday, 18 September 2015**. Sealed tenders, endorsed with the corresponding tender number and description "**BID NO. 01/08/2015: UPGRADING OF SEWER RETICULATION: NORVALSPONT**", must be placed in the tender box in the foyer of Umsobomvu Municipality, **21A Church Street, Colesberg**.

The following tender conditions but not limited to, are also included in the tender documents: • The tender offer validity period is 90 days • Bidders must submit a certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 30 days • Audited financial statements must be submitted with the bid covering at least three previous financial years (if the tendered amount exceeds R10 million including VAT) • The Bidder must supply any particulars of contracts awarded by an organ of state for the past 5 years including particulars of any material non-compliance or disputes concerning the execution of such a contract • A valid, original current SARS Tax Clearance Certificate in respect of Income and VAT must be attached to the bids • Bidders must have certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents • The bid will be adjudicated on the following criteria: Price = 90 points. BBBEE contribution level = 10 points • This bid is subject to the General Conditions of Contract 2010 (2nd edition).
