- Bids to hold goods for 90 days.
- Suppliers must be registered on the Central Supplier Database (CSD) and attached a proof of valid CSD registration report printout be submitted.
- MBD 4, 6.1, 7.1, 8 and 9 forms/declaration of interest be obtained at Umsobomvu Municipality must be completed and signed.
