NOUPOORT: UPGRADING OF GRAVEL STREET TO CONCRETE BLOCK PAVED ROAD TENDER NOTICE AND INVITATION TO TENDER

Umsobomvu Local Municipality hereby invites small to medium size construction companies from the Civil Engineering Industry **within the boundaries of Umsobomvu to Submit Tenders** to construct Voortrekker Street in Noupoort from gravel to concrete block paved street.

The street is 600 meters in length and 14 meters wide. The scope of works will include but not limited to: Excavation of existing compacted gravel street to a minimum depth of 300 mm below existing concrete channel, preparation of the roadbed, construction of 100 mm thick sub-base, 130 mm thick base and repair damaged concrete channels, edge beams, kerbs and packing of 60 mm interlocking paving bricks and trimming of the adjacent natural slopes. Bill of Quantities will be distributed during the briefing session.

- It is estimated that tenderers should have a CIDB contract grading designation of up to 3CE or higher.
- Manager with NQF Level 5
- Supervisor with NQF Level 2
- Admin Clerk with MS word and MS Excell (Computer Skills)

The tenderers are also required to submit a **team balancing sheet** listing all the activities and time frames each task will take. Subsequently to this tenderers must also reflect clearly on the **team balancing sheet the quantity of Participants (labourers) and time required to deliver the project.**

The Umsobomvu Municipality Procurement and Supply Chain Management Policies, the preferential Procurement Policy Framework Act, Act No 5 of 2000 and the regulations promulgated under this act shall apply in the adjudication and awarding of the Tender.

A compulsory site inspection meeting with representatives of the Employer will take place at the Municipal Offices in, Noupoort on the **12 July 2016 starting at 10:00 am**. Persons arriving later than **10:15** will not be allowed into the meeting. Only tenderers who attend compulsory site inspection meeting are eligible to submit tenders.

The Closing time for receipts of tenders is **12:00 on Friday, 22 July 2016**. Sealed proposals, endorsed with the corresponding tender number and description, must be placed in the tender box at the foyer of **Umsobomvu Local Municipality, 21A Church Street, Colesberg.**

The following tender conditions but not limited to, also apply for the purpose of this tender.


- The tender offer validity should hold for 90 days from the date the tender closes.
- Bidders must submit a certificate certifying that the bidder has no undisputed commitments for municipal

services towards a municipality or service provider i.r.o payments which is overdue more than 30 days.

- An Original current SARS Tax Clearance Certificate in respect of income and VAT must be attached to the tender.
- Bidders must have certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents.
- The bid will be adjudicated on the following criteria: 80 points for price, BBBEE contribution level=20 points.

Only Tenderers who satisfy the eligibility criteria stated in this advert are eligible to submit proposals.
