## REQUEST FOR QUOTATION

## Description

Umsobomvu requires chemicals for the treatment of Ventilation Improved Pit toilets (VIP Toilets). The chemical compound should be of such nature that the toilets can be used while the toilet is being treated.

NB: The quotation should include a sample to be used on one toilet to verify the performance of the chemicals, as well as directions for use and should specify the quantity and frequency to be used per toilet. References with full contact details should be included of clients serviced in the recent past.

Delivery should be F.O.R. Colesberg Municipal Workshop.

All quotes will be adjudicated and awarded in terms of the Umsobomvu Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act. This bid is subject to the General Conditions of Contract and, if applicable, any other Special Conditions of Contract.
- 5. Suppliers must submit their quotes with the following documentation and or information:
- 5.1 A valid original Tax Clearance certificate;
- 5.2 A certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 30 days;
- 5.3 Bids to hold good for 90 days.
- 5.4 Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies.
- 5.5 Suppliers must be registered on the Central Supplier Database (CSD) with compliant tax status.

- 5.6 MBD 4 forms/declaration of interest be obtained at Umsobomvu Municipality must be completed and signed.

The Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or only part of a bid if (a) the bid amounts received are too high; (b) the bids do not comply with the specific bid goals; or (c) objective criteria exist which justify or necessitate the non-acceptance of any bids.
