A total number of 93 disconnections/blocking has been performed in this quarter and has been reconnected after payments/arrangements have been made.

A total number of 165 complaints have been logged at Customer care and 105 has been resolved. The remainder relates to material needed which has been ordered to resolve these issues. The over consumption by Indigent consumers has been reduced to 17000kl and is the initiative on going to reduce these consumption. The leaking of solar geysers is one of the main causes of this consumption.

A total of 62 issues with billing incorrectness were investigated and resolved on debtor accounts.
