

## **UMSOBOMVU MUNICIPALITY REQUEST FOR PRICE**

Suitably qualified and experienced Service Providers are hereby invited to submit written price quotations in terms of the Municipal Finance Management Act, 2003, (Act 56 of 2003) for the repair of the inspection pit at the Colesberg Vehicle Test Station. Sealed proposals, endorsed with the corresponding proposal description: **RFP 1/6/2014 Repairs: Vehicle Test Station** must be placed in the Bid Box at the office of Umsobomvu Municipality, 21 A Church Street, COLESBERG. Postal delivery must reach Umsobomvu Municipality, Private Bag X 6, COLESBERG, 9795, not later than **12:00 on Wednesday, 18 June 2014**, after which the bids will be opened in public. Prices are to be firm for 90 days. No documents are available and bidders must submit a supply a detailed work schedule and pricing schedule.

### **BIDDERS MUST PLEASE NOTE THE FOLLOWING BID CONDITIONS:**

1. Bids which are deposited late, incomplete, unsigned, or submitted per facsimile or electronically will not be considered. No reason for the rejection of a bid shall be provided and the client shall not enter into any correspondence regarding this.
2. All bids will be adjudicated and awarded in terms of the Umsobomvu Supply Chain Management Policy, the Preferential Policy Framework Act 2000 (Act No. 5 of 2000) and the regulations promulgated under this Act, value for money and, capability to execute the contract.
3. The Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or only part of a bid if (a) the bid amounts received are too high; (b) the bids do not comply with the specific bid goals; or (c) objective criteria exist which justify or necessitate the non-acceptance of any bids.
4. Bids are to hold good for a period of 90 days.
5. Bidders must submit a certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 30 days.
6. An original current SARS Tax Clearance Certificate in respect of Income and VAT for both the company as well as directors must be attached to the bid.
7. Bidders must submit certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents.
8. The bid will be adjudicated on the following criteria: Price = 80 points. BBBEE contribution level = 20 points.
